

**BYLAW NO 17-2010  
OF THE TOWN OF SLAVE LAKE**

(hereinafter referred to as "the Municipality")  
**IN THE PROVINCE OF ALBERTA**

**This bylaw amends Bylaw 21-2009 Arena Borrowing Bylaw.**

**WHEREAS:**

The Council of the Municipality has passed Bylaw 21-2009 Arena Borrowing authorizing the issuance of a debenture of **THREE MILLION THIRTY THOUSAND DOLLARS (\$3,030,000.00)** in respect of the project known as the Recreation Centre renovation and upgrade, the total cost of which project is estimated to be **NINE MILLION DOLLARS (\$9,000,000.00)**;

**AND WHEREAS:**

Pursuant to the provisions of the Municipal Government Act, the Council of the Municipality wishes to increase the borrowing authorized in respect of the aforesaid project;

**NOW, THEREFORE, THE COUNCIL OF THE MUNICIPALITY DULY ASSEMBLED, ENACTS AS FOLLOWS:**

1. The purpose of this bylaw is to authorize the borrowing of additional monies to finance the cost of the project known as the Recreation Centre renovation and upgrade;
2. The authorized expenditure for the project shall remain the same as provided by Bylaw 21-2009 namely **NINE MILLION DOLLARS**;
3. The borrowing in the amount of **THREE MILLION THIRTY THOUSAND DOLLARS (\$3,030,000.00)** for the project authorized by Bylaw 21-2009 is hereby increased **FOUR HUNDRED FIFTY FOUR THOUSAND DOLLARS (\$454,000.00)** to **THREE MILLION FOUR HUNDRED EIGHTY FOUR THOUSAND DOLLARS (\$3,484,000.00)**.
4. The Provincial Grants allocated to the project of **ONE MILLION SIX HUNDRED TWENTY THOUSAND DOLLARS** is hereby reduced by **FOUR HUNDRED FIFTY FOUR THOUSAND DOLLARS (\$454,000.00)** to **ONE MILLION ONE HUNDRED SIXTY SIX THOUSAND DOLLARS (\$1,166,000.00)**;

5. This by-law comes into force on the date it is passed.

**BYLAW NO 21-2009  
OF THE TOWN OF SLAVE LAKE**

(hereinafter referred to as "the Municipality")

**IN THE PROVINCE OF ALBERTA**

**This bylaw authorizes the Council of the Municipality to incur indebtedness by the issuance of debenture(s) in the amount of \$3,030,000 for the purpose of construction of the Recreation Centre renovation and upgrade.**

**WHEREAS:**

The Council of the Municipality has decided to issue a by-law pursuant to Section 258 of the *Municipal Government Act* to authorize the financing, undertaking and construction of the Recreation Centre renovation and upgrade.

Plans and specifications have been prepared and the total cost of the project is estimated to be \$9,000,000 and the Municipality estimates the following grants and contributions will be applied to the project:

Capital Reserves	\$2,000,000
Provincial Grants	1,620,000
Other Grants	1,850,000
Donations and Sponsorships	500,000
Debenture	<u>3,030,000</u>
Total Cost	<u>\$9,000,000</u>

In order to complete the project it will be necessary for the Municipality to borrow the sum of \$3,030,000, for a period not to exceed 30 years, from the Alberta Capital Finance Authority or another authorized financial institution, by the issuance of debentures and on the terms and conditions referred to in this bylaw.

The estimated lifetime of the project financed under this by-law is equal to, or in excess of 30 years.

The principal amount of the outstanding debt of the Municipality at December 31, 2008 is \$21,419,196 and no part of the principal or interest is in arrears.

All required approvals for the project have been obtained and the project is in compliance with all *Acts* and *Regulations* of the Province of Alberta.

**NOW, THEREFORE, THE COUNCIL OF THE MUNICIPALITY DULY ASSEMBLED, ENACTS AS FOLLOWS:**

1. That for the purpose of construction of the Recreation Centre renovation and upgrade the sum of THREE MILLION THIRTY THOUSAND (\$3,030,000) be borrowed from the Alberta Capital Finance Authority or another authorized financial institution by way of debenture on the credit and security of the Municipality at large, of which amount the full sum of \$3,030,000 is to be paid by the Municipality at large.
2. The proper officers of the Municipality are hereby authorized to issue debenture(s) on behalf of the Municipality for the amount and purpose as authorized by this by-law, namely the construction of construction of the Recreation Centre renovation and upgrade.
3. The Municipality shall repay the indebtedness according to the repayment structure in effect, namely semi-annual or annual equal payments of combined principal and interest instalments not to exceed THIRTY (30) years calculated at a rate not exceeding the interest rate fixed by the Alberta Capital Finance Authority or another authorized financial institution on the date of the borrowing, and not to exceed TEN (10) percent.
4. The Municipality shall levy and raise in each year municipal taxes sufficient to pay the indebtedness.
5. The indebtedness shall be contracted on the credit and security of the Municipality.
6. The net amount borrowed under the by-law shall be applied only to the project specified by this by-law.
7. This by-law comes into force on the date it is passed.

READ A SECOND TIME THIS 20 DAY OF April 2010.
