RESCINDING Bylaw

A BYLAW OF THE TOWN OF SLAVE LAKE, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF RESCINDING NON-CURRENT AND OR OUTDATED BYLAWS.

WHEREAS, pursuant to the provisions of the *Municipal Government Act* (the "Act") Chapter M-26, revised statues of Alberta, section 63;
